- 2. There will be no audio or visual recording of meeting; minutes of meetings will be brief overviews of topics discussed and will be placed on the website.
- 3. All Decision Making Workgroup members agree to make an effort to attend all workgroup meetings; however, we recognize that members may have other obligations.
  - a. Each member must designate one proxy to vote in their stead.
  - b. If members are unable to attend the meeting, they must arrange for their designated proxy to attend.
  - c. Two absences in a row without prior notice or designated proxy signify a resignation from the Decision Making Workgroup.
- 4. Workgroup decisions:
  - a. Workgroup will approve recommendations by consensus.
  - b. If consensus cannot be reached, then recommendations will be approved by 2/3 majority
- 5. Professional conduct is expected.
