- Watershed Road Signs
 - Hays County is waiting on map for right of ways
 - Will be installed by the end of October/early November
- o Best Management Practices (BMP) Education Signs
 - All BMPs are done except Wimberley Valley Watershed Association (WVWA) vegetated filter strip (VFS) project
 - Adding Spanish translation to signs, installation is expected to be complete by late September or early October.
- Project Completion Schedule
 - Contract will end in February, new contract will begin March 2020
 - WVWA VFS will be done by October
 - Continuing monitoring efforts in Wimberley Valley

- Texas Stream Team
 - Focusing on revamping efforts in Wimberley Valley, any volunteers interested in monitoring their local tributaries or would like to train citizens to become water quality monitors please email txstreamteam@txstate.edu
- City of Wimberley
 - Working with Tom Hegemier to update water quality ordinances
 - Still in negotiations with Aqua Texas and landowners for easements to cross the creek
 - The City is asking for ways to get reuse water to the Blue Hole Park if wastewater is collected by Aqua Texas. Please send ideas over to the City directly.

 - Working on ways to incentivize Green Stormwater Infrastructure (GSI) Projects
 - Utilizing conservation development (Chapter 765)

 - Organizing research study in western Hays County with dye tracing studies in the Trinity aquifer.
 - Looking at land areas that can be converted into park and preserve combos for all of the Precincts.
